# **Assignment Objective**

Environmental and Social safeguard advisor will be embedded within the Industrial Parks Development Corporation (IPDC) HQ office to provide technical advice on environmental sustainability and compliance with local and international environmental regulations. The Environmental Advisor will support the environmental sustainability outputs of the S.I.C. II project by advising the IPDC on integrating environmental considerations into the planning, operation, and management of industrial parks. The Advisor will work to ensure compliance with environmental regulations, promote sustainable industrial practices, and contribute to the development of strategies that align with IPDC's requirement and the S.I.C. II project's goals of reducing greenhouse gas emissions, eco-friendly operations, and sustainable economic growth.

# **Context / Background**

The Ethiopian Industrial Parks Development Corporation (IPDC) was established in December 2014 as public enterprise aimed enhancing the industrialization effort of the country. IPDC is an engine of rapid industrialization that nurture manufacturing industries that accelerate economic transformation, promote and attract both domestic and foreign investors. The industrial Parks that IPDC manages and operate are expected to be equipped with a streamlined business environment, common services and quality infrastructure that enable a single, efficient, and streamlined IP administration for investors.

S.I.C. II project has the objective to strengthen the resilience of Ethiopia's textile and garment sector by applying a demand- and market-oriented approach in its support to workers, manufacturers and the government. It aims at promoting worker welfare; preparing companies to align with international market requirements; attracting international buyers to sourcing from Ethiopia; advising the management of IPs on sustainable operations and offering policy advisory to ease business environment constraints.

The purpose of this secondment is to utilize the Advisor's expertise to elevate IPDC's sustainability efforts, enhance its Environmental, Social and Governance (ESG) frameworks, and ensure that sustainability is embedded in its operational and strategic decision-making. The Advisor will also play a critical role in promoting sustainable industrial practices within the Corporation's industrial parks, including resource efficiency, renewable energy adoption, and waste management.

#### Key tasks (Responsibilities and Duties)

This assignment has the following key tasks:

- 1. Strategic Environmental Planning and Policy Advisory:
  - Support the IPDC in developing and implementing environmental management strategies that comply with national policies and international standards.
  - Advise on best practices in environmental governance, pollution prevention, resource efficiency, and waste management within industrial parks.
  - Provide policy recommendations to the Ethiopian government on strengthening the environmental regulatory framework in line with global sustainability practices.

#### 2. Sustainable Practices and Innovation:

• Promote the adoption of eco-friendly technologies and practices among manufacturers operating within the industrial parks.

 Facilitate capacity-building initiatives for industrial park management and staff on sustainability topics such as renewable energy, circular economy principles, and green supply chain management.

#### 4. Engagement with International Buyers and Investors:
